The board has reduced the prices of consumer durable items substantially with transparent offers. We are taken more care in the higher purchase Loan facility for the members and we already enhanced the consumer loan amount as well as many MELAS/ exhibition with many home appliances company were carried out for the benefit of the members.

The distribution of PDS (Ration) items has been carried out with meticulous care and we are taking care of distributing the Pongal gifts of TN Government and distributed the Dhoti & Saree to our Members after the many decades of the Store's history.

Regarding Losses of Stores:

The losses has been started in the year 2017-18 auditing period of previous committee due to closing of the Pharmacy business at the year 2017 and 14 nos.temporary staffs were made permanent by them is the prime reason for the losses. Our committee has taken the charge in the August- 2018 which comes under the 2018-19 audit period. Hence, one side the Pharmacy business was closed and other side 14 nos. temporary staffs were made permanent which reduces the income and enhance the expenditure of the Stores.

- As every one of you are aware, our Co-op. Store account is audited by Tamil Nadu State Government Auditors.
- Due to malicious interested persons' fabricated complaint against our committee, many times the
 accounts of Co-op. Stores were subjected to verification of State Government and the year
 2022 by the Central Vigilance Committee (CVC). Five year auditing report and other documents
 etc., were verified by them and they confirmed that the losses is mainly due to Establishment
 charges (staff salary, increment, DA, bonus etc.,)
- After taking over charges, we conducted two general body meeting and submitted audited balance sheet for 5 years (including previous committee's accounts) and the same approved by members. In the general body meeting held in 2019, our committee informed that as the stores is functioning with serious loss because of closure of Pharmacy and 14 temporary staffs were made permanent, as per rule of cooperative it is unable to provide dividend to members. However it was decided to provide purchase bonus instead of dividend and everyone is aware the same being issued to members every year from 2019 onwards. But only few malicious persons are unaware of the fact. Whether they are under coma status or making foundation by propagating false information to members to win the forth coming co-operative election for continue their immoral activities?
- As they are expert in crabbing money, they have targeted now on stores.

It is better to know about the rules and regulations of the cooperative Stores and the duty responsibility of the staffs and the supremacy of honorary managing committee (BOARD) of the Stores.
